

## BonusLink MINI Fiesta Contest

### Terms and Conditions

#### (A) GENERAL

1. The 'BonusLink MINIFiesta' Contest (hereinafter referred to as the "**Contest**") is open to all BonusLink Primary and Supplementary Members ("**BonusLink Members**") who are residing in Malaysia and are above 18 years of age ("**Eligible Participants**"), except employees of BonusKad Loyalty Sdn Bhd ("**BonusLink**"), partners and affiliates of BonusLink, media and advertising/promotion agencies engaged by BonusLink, and the immediate family members of the said employees. Immediate family members shall mean father, mother, brother, sister, spouse and/or child.
2. Contest will commence from 1 July 2018 to 31 August 2018 ("**Contest Period**").
3. BonusLink reserves the right to disqualify any person that it knows is, or has reasonable grounds to believe is, ineligible for this Contest as a result of the terms and conditions ("**Terms and Conditions**") herein.
4. A BonusLink Member will qualify for this Contest by using his/her BonusLink Card in a manner that fulfills any of the following criteria during the Contest Period:
  - (a) **Physical Card Swipes**

Contest is applicable to all physical card swipes made at a BonusLink Partner's outlet in Malaysia during the Contest Period. BonusLink Points ("**Points**") collected at the outlets will be considered as valid entries. A full list of BonusLink Partners can be found at <https://www.bonuslink.com.my/EN/Partners.aspx>.

1 physical card swipe, with no minimum spend = one (1) Contest entry.
  - (b) **Logical and Virtual Card Swipes**

Contest is applicable to all logical/virtual card swipes, which refers to transactions made via online/virtual BonusLink Partners such as AmBank, Public Bank, Agoda.com/BonusLink, eforex.com, eremit.com and e-pay.

1 logical/virtual card swipe, with no minimum spend = one (1) Contest entry.
  - (c) **Redemption**

Every redemption made by a BonusLink Member during the Contest Period will be entitled to one (1) Contest entry. For the avoidance of doubt, only redemptions made via the BonusLink website, BonusLink App, Self-Service Phone System, at On-The-Spot Partners outlets and/or mail/fax will qualify.
  - (d) **New AmBank BonusLink Visa Card Application**

New AmBank BonusLink Visa Card members who apply for the said co-branded credit card during the Contest Period and whose applications are successful and approved by the said issuing bank on or before 31 August 2018 will be entitled to ten (10) Contest entries.
5. BonusLink Members are not required to fill-up any Contest forms. Entries will be automatically recorded via a pre-determined electronic system as soon as practicable once any of the criteria in paragraph 4 above is met.

6. If a BonusLink Card is not swiped or no Virtual Card Swipe is made at the time of purchase or transaction, there will be no entry/entries recorded to enable participation in the Contest. BonusLink reserves the right to disqualify any entries recorded for the Contest.
7. Points collected from BonusLink promotions including Points obtained from transacting with short term Partners will not qualify.

**(B) WINNERS SELECTION & ANNOUNCEMENT**

8. Winners will be selected and announced based on the following schedule:

9. For the avoidance of doubt, shortlisted winners will be selected from a pool of valid entries via a Winner’s Selection Software. BonusLink will contact the shortlisted winner who is the registered owner of the BonusLink Card with the valid entry.
10. A shortlisted winner will be contacted by BonusLink via a phone call (“**Phone Call**”). For example:
 

Should the first attempt to contact a shortlisted winner via Phone Call fail, i.e. no answer, telephone number not in service, no connection etc, BonusLink will attempt to contact the shortlisted winner again at least two (2) more times on the same/next day from when the first call attempt was made. Where such further attempts to contact the shortlisted winner are unsuccessful, BonusLink reserves the right to select another shortlisted winner through a Phone Call, in place of the original shortlisted winner who could not be contacted and the same process will be repeated until a new shortlisted winner is determined.

Once the shortlisted Winner receives a Phone Call and the required identity verification is completed, the shortlisted winner will be required to answer BonusLink related questions correctly before they are eligible to receive the Prize (“**Winner**”). If any answer to any question is incorrect, he/she will be disqualified from the Contest and another Winner will be selected.
12. For the avoidance of doubt, a BonusLink Member may only be a Winner only once throughout the Contest Period.
