BonusLink Win 3 BMW X3 Contest

Terms and Conditions

(A) GENERAL

- 1. The 'BonusLink Win 3 BMW X3' Contest (hereinafter referred to as the "Contest") is open to all BonusLink Primary and Supplementary Members ("BonusLink Members") who are residing in Malaysia and are above 18 years of age ("Eligible Participants"), except employees of BonusKad Loyalty Sdn Bhd ("BonusLink"), partners and affiliates of BonusLink, media and advertising/promotion agencies engaged by BonusLink, and the immediate family members of the said employees. Immediate family members shall mean father, mother, brother, sister, spouse and/or child.
- 2. Contest will commence from 23 September to 24 November 2019 ("Contest Period").
- BonusLink reserves the right to disqualify any person that it knows is, or has reasonable grounds to believe is, ineligible for this Contest as a result of the terms and conditions ("<u>Terms and</u> <u>Conditions</u>") herein.
- 4. This Contest is divided into 2 tiers. Eligible Participants are entitled to participate in this Contest upon the fulfillment of the following:

Tier 1:

- a. Eligible Participants must be an existing BonusLink Member and the Eligible Participant's BonusLink Card must be swiped prior to the Transaction (as defined in clause 4 Tier 1(b)) taking place to be considered as a valid entry; and
- b. The Eligible Participant must carry out a **minimum purchase of Ringgit Malaysia Forty** (RM40) at any participating Shell Stations, cumulative within the day during the Contest Period ("Qualifying Purchases"); and
- c. Qualifying Purchases include:
 - i. Shell fuels, namely Shell FuelSave 95, Shell FuelSave Diesel, Shell FuelSave Diesel Euro 5, Shell V-Power 97, and Shell V-Power Racing;
 - ii. any of the following Shell Lubricants (Shell Helix, Shell Advance, or Shell Rimula); and
 - iii. any products sold within Shell Select premises at Shell Stations except tobacco products, E-Pay products (U-Mobile, Hotlink, Digi, Celcom etc.) and Touch 'N Go purchases.

<u>Important Note</u>: (1) All products purchased at drive-through outlets, co-locators, and lube-bays located at Shell Stations are not Qualifying Purchases for the purposes of this Contest. (2) Qualifying Purchases paid via the redemption of BonusLink Points are allowed.

Every RM40 spend at any Shell stations, cumulative within the same day = one (1) Contest entry

Every RM40 spend at Shell cumulative in the same day with an AmBank BonusLink Visa Card = two (2) Contest entries

(Collectively, referred to as the "Pre-requisites".)

Tier 2:

Eligible Members who fulfilled Tier 1 AND are selected as the Winners (as defined in clause 16) AND swiped their BonusLink Card to collect a minimum of 1 BonusLink Point at any other BonusLink Partner* within the Contest Period will win EXTRA 30,000 BonusLink Points on top of the standard Points collected. Scenarios for Tier 1 and Tier 2 are illustrated in clause 8 below.

- * BonusLink Partners are listed at bonuslink.com.my. Only Points collected at these BonusLink Partners' listed at outlets will be considered as valid entries. For the avoidance of doubt, transactions received from BonusLink Partners will include all logical/virtual card swipes, which refers to transactions made via online/virtual BonusLink Partners such as AmBank, Public Bank, Agoda.com/BonusLink, eforex.com, eremit.com and e-pay.
- 5. Points collected from BonusLink promotions including Points obtained from transacting with short term Partners and social media Contest will not qualify.
- 6. Eligible Participants are not required to fill-up any Contest forms. Each time an Eligible Participant fulfils the Pre-requisites during the Contest Period, it is deemed that they have submitted valid entries to participate in the Contest ("Valid Entries"), the quantity of which is determined as follows:
 - a. A pre-determined electronic system will accumulate the total value of all Qualifying Purchases on the same day that the Pre-requisites were met ("Qualifying Purchase Value").
 - b. Then, the Qualifying Purchase Value is divided by Ringgit Malaysia Forty (RM40.00) and rounded down to the closest whole number to determine the number of Valid Entries submitted by the Eligible Participant on that given day.

For example, if the Qualifying Purchase Value is Ringgit Malaysia One Hundred (RM100.00), the Eligible Participant is deemed to have submitted two (2) Valid Entries.

- 7. If a BonusLink Card is not swiped or no Virtual Card Swipe is made at the time of purchase or transaction, there will be no entry/entries recorded to enable participation in the Contest.

 BonusLink reserves the right to disqualify any entries recorded for the Contest.
- 8. Scenarios for the Contest: -

Eligible Participant who fulfils the Pre-requisites during the Contest Period stand a chance to win the Grand Prize or Consolation Prize, while the Extra 30,000 BonusLink Points will be awarded to Eligible Participants who fulfil Clause 4, Tier 2 above:

- 10. For the avoidance of doubt, shortlisted winners will be selected from a pool of valid entries via a Winner's Selection Software. BonusLink will contact the shortlisted winner who is the registered owner of the BonusLink Card with the valid entry.

Should the first attempt to contact a shortlisted winner via Phone Call fail, i.e. no answer, telephone number not in service, no connection etc, BonusLink will attempt to contact the shortlisted winner again at least two (2) more times on the same/next day from when the first call attempt was made.
