

BonusLink 12 Days to Christmas

Terms and Conditions

(A) GENERAL

1. The '12 Days to Christmas' Contest (hereinafter referred to as the "**Contest**") is open to all BonusLink Primary and Supplementary Members, including those who have successfully registered as a [BonusLink Primary and/or Supplementary Member], at the point of sale ("**BonusLink Members**") who are residing in Malaysia and are above 18 years of age, except employees of BonusKad Loyalty Sdn Bhd ("**BonusLink**"), partners and affiliates of BonusLink, media and advertising/promotion agencies engaged by BonusLink, and the immediate family members of the said employees ("**Eligible Participants**"). Immediate family members shall mean father, mother, brother, sister, spouse and/or child.
2. The Contest will commence from 13 December 2019 to 24 December 2019 ("**Contest Period**").
3. BonusLink reserves the right to disqualify any person that it knows is, or has reasonable grounds to believe is, ineligible for this Contest as a result of the terms and conditions ("Terms and Conditions") herein.
4. In order to participate in this Contest, an Eligible Participant shall:
 - (a) **Qualified Products**
purchase at least one product that qualifies for BonusLink Points ("**Qualified Product**").
 - (b) **Physical Card Swipes or Virtual Card**
either Swipe its physical card (BonusLink Card or AmBank BonusLink Visa Card) or Use/flash the BonusLink Virtual Card via BonusLink App ("**Card**") for the relevant purchase at participating Partner's outlet in Malaysia during the Contest Period.(Collectively, referred to as the "Pre-requisites".)
5. This Contest is divided into 3 Tiers. Eligible Participants are entitled to participate in this Contest upon the fulfillment of the following:
 - a. **Tier 1**
Eligible Participants who swipe at ANY participating BonusLink Partner will be entitled to 1 Contest Entry
 - b. **Tier 2**
Eligible Participants who swipe at two or more Participating BonusLink Partner during the Contest period will be entitled to an Extra 2 Bonus Entries.

c. Tier 3

Eligible Participants who fulfilled Tier 1 AND/OR Tier 2 and pay with the AmBank BonusLink Visa Card at participating BonusLink Partner will be entitled to an Extra 3 Bonus Entries

* BonusLink Partners are listed at bonuslink.com.my. Only Points collected at these BonusLink Partners' listed at outlets will be considered as valid entries. For the avoidance of doubt, transactions received from BonusLink Partners will include all logical transactions such as that received from AmBank and Public Bank as well as online transactions such as that received from Agoda.com/BonusLink, eforex.com and eremit.com.

- Each time an Eligible Participant fulfils the Pre-requisites during the Contest Period, it is deemed that they have submitted valid entries to participate in the Contest ("Valid Entries").

(B) WINNERS SELECTION & ANNOUNCEMENT

- For the avoidance of doubt, shortlisted winners will be selected from a pool of valid entries via a Winner's Selection Software. BonusLink will contact the shortlisted winner who is the registered owner of the BonusLink Card with the valid entry.
- A shortlisted winner will be contacted by BonusLink via a phone call ("Phone Call"). For example:

Should the first attempt to contact a shortlisted winner via Phone Call fail, i.e. no answer, telephone number not in service, no connection etc, BonusLink will attempt to contact the shortlisted winner again at least two (2) more times on the same/next day from when the first call attempt was made. Where such further attempts to contact the shortlisted winner are unsuccessful, BonusLink reserves the right to select another shortlisted winner through a Phone Call, in place of the original shortlisted winner who could not be contacted and the same process will be repeated until a new shortlisted winner is determined.

- Once the shortlisted Winner receives a Phone Call and the required identity verification is completed, the shortlisted winner will be required to answer BonusLink related question correctly before they are eligible to receive the Prize ("Winner"). If any answer to any question is incorrect, he/she will be disqualified from the Contest and another Winner will be selected.
- For the avoidance of doubt, a BonusLink Member may only be a Winner only once throughout the Contest Period.
