

## **“SHELL BONUSLINK 10X POINTS” TERMS & CONDITIONS**

1. The Shell BonusLink 10X Points (“**Program**”) will commence from 12:00:00 AM on Wednesday, 4 December 2019 until 11:59:59 PM on Friday, 6 December 2019 (“**Program Period**”) and is applicable at all Shell retail stations in Malaysia (“**Shell Stations**”).
2. This Program is organised by BonusKad Loyalty Sdn Bhd (“**BonusLink**”) and is open to all registered BonusLink Members with residential or correspondence address in Malaysia (“**Members**”) who are also customers of Shell Malaysia Trading Sdn Bhd and/or Shell Timur Sdn Bhd (collectively, referred to as “**Shell**”).
3. With this Program, Members will receive ten (10) BonusLink Points (“**10X Points**”) for every one (1) litre of fuels purchased at Shell Stations during the Program Period. Eligible fuels are as follow:
  - (i) **Shell FuelSave 95**
  - (ii) **Shell FuelSave Diesel**
  - (iii) **Shell FuelSave Diesel Euro 5**
  - (iv) **Shell V-Power 97**
  - (v) **Shell V-Power Racing**(Collectively, referred to as “**Shell Fuels**”)
4. To be eligible for this Offer, Members are required to swipe their BonusLink Card at Shell Stations during the Program Period, at the point of Shell Fuels purchase. (or present the BonusLink App to Cashiers in-store)
5. The 10X Points will be awarded to the eligible Member within three (3) working days from date of Shell Fuels purchase, up to a maximum of 15,000 Points per day. For manual transaction journals (“**MTJ**”) submitted for Shell Fuels purchase transactions by authorised Shell dealers, the 10X Points will be awarded to Members within six (6) to eight (8) weeks from the date of submission of the MTJ to BonusLink.
