

BonusLink Pit Stop Challenge Campaign

Terms & Conditions Effective as at 17TH July 2020

Campaign Period

- 1.0 This Pit Stop Challenge Campaign (“Campaign”) organised by BonusKad Loyalty Sdn Bhd 199701022703 (438200-T) will commence from 17th July 2020 to 16th October 2020 (both dates inclusive) (“Campaign Period”)

Eligibility

- 2.0 Subject to these Terms and Conditions, this Campaign is open to Existing or New BonusLink Members, who are residing in Malaysia and are above 18 years of age and are in the following categories:

Member Status	Description
Existing Member	A person with an Existing BonusLink Card Number
New Member	A person who successfully registers as a BonusLink Member during the Campaign


- 3.0 In order to be eligible to participate in the Campaign, BonusLink Members are required to perform specific activities:
- 3.1 Existing and New BonusLink Members must download and install the New BonusLink Mobile App from the Google Play Store or the Apple App Store on their Android or iOS device(s) respectively
- 3.2 Existing and New BonusLink Members are required to complete the setup of One Time Password (OTP)
- 3.3 Existing BonusLink Members are required to pair their physical BonusLink Card Number to the BonusLink Mobile App
- 3.4 New applicant who successfully registered to be BonusLink Member via BonusLink Mobile App will be given a Virtual Membership Number.

Campaign Mechanics

- 4.0 To qualify, BonusLink Members are required to perform various activities to be awarded with Reward(s) during the Campaign Period:
- Link a Debit or Credit card
In order to qualify for this Campaign, Member is required to link either their Debit or Credit card to the BonusLink Mobile App
Note: Only applicable to the first successful registered Debit or Credit Card only. To qualify, Payment Card must remain linked throughout campaign period. Subject to first come first serve basis.
 - Purchase a voucher via the BonusLink Mobile App or Scan / swipe with your BonusLink Card
A Member will qualify for this campaign by performing either one of the criteria with a minimum spends of RM30.
 - Scan or swipe your BonusLink Card at a BonusLink Partner or Merchant outlet. BonusLink Card must be scanned or swiped prior to the transaction to be considered as a valid transaction.
 - Purchase of any Vouchers to be made directly from the BonusLink Mobile App.
Note: Applicable to the first transaction only.

- Refer a Friend
In order to qualify for Refer a Friend Campaign's task, Member is required to perform below activities via BonusLink Mobile App:
 - 1) Get a Referral code from Member Profile Page send the "Referral Code" via the following method below:
 - Sharing the Referral Code via social media channels (Facebook / Twitter) or Whatsapp options
 - Copy the Referral Code page link and share with friends via Whatsapp or social media channels (Facebook / Twitter)
 - 2) The person who receives the Referral Code (Referee) is required to:
 - a) Download the BonusLink Mobile App via Google Play Store or Apple App Store
 - b) Key in the Referral Code
 - c) Set up OTP (One Time Password) registration.

Note: Applicable to New BonusLink Mobile App downloads (Referee) only.

- Transfer a Voucher
In order to qualify for this Campaign's task, Member is required to do the following via BonusLink Mobile App:
 - 1) Click at "Deals page"
 - 2) Purchase a Voucher with "Gift icon"  via payment card (Debit / Credit card linked to the BonusLink Mobile App) and or redeem via BonusLink Points.
 - 3) Go to "View Wallet" and send the purchased "Shareable Voucher" to your family or friends by entering their mobile number or send via QR code option
 - 4) Recipient of the voucher will receive a notification to download the "Transfer Voucher" within a stipulated time period. Failing which the voucher will be returned to the sender.

Note: Applicable to only the first successful transfer only.

Rewards

- 5.0 The Eligible BonusLink Members who have completed the "Campaign Tasks" will be rewarded as follow:

- To qualify, Payment Card must remain linked throughout campaign period.
- 5.2 Purchase a voucher via BonusLink Mobile App or Scan / swipe with your BonusLink Card with a minimum spend of RM30
- First 10,000 Members who successfully meet spend criteria: 500 BonusLink Points
- Or
- Subsequent 150,000 Members who successfully meet spend criteria: 100 BonusLink Points
