

TERMS AND CONDITIONS – “WOW WEDNESDAY” Promotion

1. The “WOW WEDNESDAY Promotion” (“**Promotion**”) is jointly organized by Shell Malaysia Trading Sdn Bhd (Company No. 196501000279 (6087-M)) and Shell Timur Sdn Bhd (Company No. 198401000783 (113304-H)), collectively known as “**Shell**”.
2. The Promotion is open to all Shell customers in Peninsular and East Malaysia (“**Customers**”) and will commence every Wednesday from 5th August 2020 (12:01AM) to 4th November 2020 (11:59PM), both dates inclusive (“**Promotion Period**”) which can be extended by Shell without prior notice.
3. This Promotion is applicable at all Shell retail stations across Malaysia as listed on www.shell.com.my/stationlocator (“**Shell Stations**”), with the exception of the Deli2go Promotion (as hereinafter defined) which is applicable only at Shell Stations with Deli2go offerings as listed on www.shell.com.my/stationlocator (“**Deli2go Sites**”).
4. **Deli2Go Promotion (Peninsular Malaysia):** The deli2go Promotion in Peninsular Malaysia includes purchase of any one (1) of the listed deli2go pastries below for RM1.80:

 - Sardine Puff, 80g
 - Tuna Puff, 80g

 - Kaya Twist / Twist Kaya, 80g
 - Curry Chicken Doughnut, 70g
 - Ikan Bilis Doughnut, 70g
 - BBQ Chicken Puff, 80g
 - Chicken Rendang Puff, 80g
 - Chicken Pizza Puff, 80g

(hereinafter collectively referred to as “**Listed Pastries in Peninsular Malaysia**”)

Promotion is not valid with any other combination of deli2go pastry and is available while stocks last.

5. To be eligible for the deli2go Promotion, Customers are required to make a minimum purchase of Ringgit Malaysia Thirty (RM30.00) only of any Shell Fuels (Shell FuelSave 95, Shell V-Power 97 or Shell V-Power Racing) and present the proof of purchase when purchasing the Listed Pastries in Peninsular Malaysia for the Deli2go Promotion.
6. **Gardenia Promotion (Peninsular Malaysia):** The Gardenia Promotion in Peninsular Malaysia includes purchase of one (1) Gardenia Original Classic 400g for Ringgit Malaysia One and Fifty Cents (RM1.50) only. Promotion is not valid with any other combination of Gardenia items and it is only available while stocks last.

7. **Maggi Hot Cup Promotion (Peninsular Malaysia)**: The Maggi Hot Cup Promotion in Peninsular Malaysia includes purchase of one (1) Maggi Hot Cup Curry 59g for Ringgit Malaysia One and Fifty Cents (RM1.50) only. Promotion is not valid with any other combination of Maggi Hot Cup items and it is only available while stocks last.
8. Further to Clause 6 and 7 above, all BonusLink Members would be able to redeem the Gardenia Promotion or Maggi Hot Cup Promotion for One Hundred (100) BonusLink Points. The offer is limited to the first ten (10) customers every Wednesday at any participating Shell Stations during the Promotion Period. Once this limit has been reached at a particular Shell Station, Customers would only be eligible to purchase the Gardenia Promotion or Maggi Hot Cup Promotion for Ringgit Malaysia One and Fifty Cents (RM1.50) while stocks last.
9. To be eligible for the Gardenia Promotion or Maggi Hot Cup Promotion, customers are required to make a minimum purchase of RM30 of Shell Fuels (Shell FuelSave 95, Shell V-Power 97 or Shell V-Power Racing) and present the proof of purchase when purchasing the items under the Gardenia or Maggi Hot Cup Promotion.

The Customers are only allowed to purchase either one (1) Deli2go Promotion, Gardenia Promotion or Maggi Hot Cup Promotion at any one time.

 - Chicken Curry Puff-Triangle, 80g

(hereinafter referred to as "**Listed Pastries in East Malaysia**")

Promotion is not valid with any other combination of deli2go pastry. This Promotion is valid while stocks last.

11. To be eligible for the deli2go promotion, Customers are required to make a minimum purchase of Ringgit Malaysia Thirty (RM30) only of Shell Fuels (Shell FuelSave 95, Shell V-Power 97 or Shell V-Power Racing) and present the proof of purchase when purchasing the Deli2go Promotion.
12. **Maggi Cup Promotion (East Malaysia)**: The Maggi Hot Cup Promotion in Peninsular Malaysia includes purchase of one (1) Maggi Hot Cup Curry 59g for Ringgit Malaysia One and Fifty Cents (RM1.50) only. Promotion is not valid with any other combination of Maggi Hot Cup items and it is only available while stocks last.
13. To be eligible for the Maggi Cup promotion, Customers are required to make a minimum purchase of Ringgit Malaysia Thirty (RM30) only of Shell Fuels (Shell FuelSave

95, Shell V-Power 97 or Shell V-Power Racing) and present the proof of purchase when purchasing the Maggi Cup Promotion.

14. Shell reserves the right to vary, delete, substitute or add to any of these Terms and Conditions at its absolute discretion at any time without prior notice or liability.
15. These Terms and Conditions, as may be amended from time to time pursuant to Clause 8 above, shall prevail over any provisions or representations contained in any other promotional material or advertising of this Promotion.
16. All decisions made by Shell in respect of this Promotion or in the event of any dispute are final and binding.
17. Shell reserves the right to cancel, terminate or suspend this Promotion with or without prior notice. In the avoidance of doubt, cancellation, termination or suspension by Shell of this Promotion shall not entitle Shell Customers to any claim or compensation against Shell for all and all losses or damage suffered or incurred by Shell Customers as a direct or indirect result of the act of cancellation, termination or suspension.
18. In no event will Shell and its Affiliates be liable for any loss or damages including without limitations, loss of income, profits or goodwill, direct or indirect, incidental, consequential, exemplary, punitive or special damages of any party including third parties howsoever arising whether in contract, tort, negligence or otherwise, in connection with this Promotion, even if Shell has been advised of the possibility of such damages are expressly excluded.
19. The invalidity, illegality or unenforceability of any terms hereunder shall not affect or impair the continuation in force of the remainder of these Terms and Conditions of this Promotion.
20. For these Terms and Conditions, "**Affiliate**" means a company which directly, or indirectly through one or more intermediaries, controls, is controlled by, or is under common control with Shell. Relevant to this, "**control**" means the direct or indirect ownership of an aggregate fifty percent (50%) or more of voting capital.
21. By participating in this Promotion, it is deemed that the Customers has read, understand and agreed to be bound by all Terms and Conditions.
22. These Terms and Conditions, as the same may be amended from time to time, shall prevail over any provisions or representations contained in any other promotional material advertising this Promotion.
