

## **TERMS AND CONDITIONS – EXTRA BONUS AT SHELL**

3. The Promotion Period is from Monday, 17 August 2020 (12:01AM) to Sunday, 27 September 2020 (11:59PM), both dates inclusive, which can be extended by Shell and BonusLink without prior notice.
