

Terms and conditions

1. This campaign (“Campaign”) is jointly organized by BonusKad Loyalty Sdn. Bhd. (“BLSB”) and Speedrent Technology Sdn. Bhd. (“SPEEDHOME”) (jointly referred to as “the Organizers”).
2. By participating in this Campaign, all BonusLink Members (“Members”) are deemed to have read, understood and expressly agreed to be bound by the Terms & Conditions of this Promotion as stated herein and any additional terms and conditions stipulated by the Organizers from time to time (as may be applicable) including the decisions of the Organizers in all matters related thereto. Information on how to participate in the Campaign shall form part of the conditions of entry in the Campaign. Registration for and/or participation in the Campaign is deemed acceptance of the conditions of entry. Acceptance of the Terms and Conditions is a condition of entry.
3. This campaign ends on 31 December 2021 23.59 unless advised otherwise by the Organizers. The Organizers reserve the right to amend or extend the duration of the Campaign at any time as deemed fit.
4. To qualify and participate in this Campaign, Members must perform the following:
 - a. Landlord and/or tenant must be an existing BonusLink Member;
 - b. Campaign is open to both landlords and tenants.
 - c. To browse for rental units, chat with prospects and schedule viewing appointments at <https://bonuslink.speedhome.com/>
 - d. Members must make successful online purchase with SPEEDHOME at <https://speedmanage.com/> (“Dedicated Website”) during the Campaign Period and enter their BonusLink Card Number at the tenancy agreement dashboard. (“Successful Order”)
 - e. For landlords, it is required to purchase or opt in to SPEEDHOME’s Basic, Extended or Extended Plus Insurance Premium.
 - f. Only eligible for rental RM500 and above.
 - g. Must enter BonusLink Card number at <https://speedmanage.com/> tenancy agreement dashboard.
 - h. Only Successful Orders made via Dedicated Website will be eligible for BonusLink Points;
 - i. BonusLink Points will be awarded to the Members on Successful Orders (excluding Speedsign Fee, 6% SST, Stamp Duty) as follows:
 - i. Every RM2 = 1 BonusLink Point.
5. BonusLink Points will only be awarded based on the first monthly rental payment, with the exclusion of Speedsign Fee, 6% SST and Stamp Duty. Any subsequent monthly rental payment via SPEEDHOME will not be eligible for BonusLink Points.

6. The Organizers reserve the absolute right, at any time, to verify the validity of Successful Orders and Members at any point in time.
7. BonusLink Points will be credited into Members' BonusLink Account after 30 days (or any other period as the Organizers deem necessary) of the agreed move in date or Successful Order subject to the Organizers receiving all necessary information as deemed necessary.
8. Retro-claims by Members for the award of BonusLink Points will not be entertained. Any request by Members to provide their BonusLink Card Number or to be eligible for BonusLink Points after agreed move in date or Successful order will not be entertained. Only Members who fulfil the Campaign terms and conditions shall be eligible for the award of BonusLink Points.
9. The Organizers reserves the absolute right to revise the BonusLink Points from time to time without any prior notice to the Members.

For the avoidance of doubt, cancellation, termination or suspension by the Organizers shall not entitle the Members to any claim or compensation against the Organizers for any and/or all losses or damages suffered or incurred as a direct or indirect result of the act of cancellation, termination or suspension.

The Terms and Conditions contained herein shall prevail over any inconsistent terms, conditions, provisions or representation contained in any other promotional or advertising materials for the Campaign. In the event of any inconsistency between the English version and any translation thereof, the English version of the Terms and Conditions shall prevail and supersede.
