## TERMS & CONDITIONS

## KK Super Mart, PrestoMall, Speedwork Autocare & Meat Cartel – BonusLink Launch Campaign 2021

- The KK Super Mart, PrestoMall, Speedwork Autocare and Meat Cartel BonusLink Launch Campaign 2021 (hereinafter referred to as the "Campaign") is run by BonusKad Loyalty Sdn Bhd ("BonusLink") and four (4) participating Partners which are KK Supermart & Superstore Sdn Bhd ("KK Super Mart"), Presto Mall Sdn Bhd ("PrestoMall"), Speedwork Autocare Sdn Bhd ("Speedwork Autocare") and Meat Cartel Holding Sdn Bhd ("Meat Cartel") (hereinafter collectively, the "Partners" and each a "Partner").

5. The Campaign Period is segregated to eight (8) Campaign weeks as below: -

6. You shall then be entitled to receive one (1) time of one thousand (1000) BonusLink Points only from each Partner for each first successful transaction made throughout the entire Campaign Period. If you have make successful transactions with all Partners within the Campaign Period, You will be entitled to a maximum total of four thousand (4000) BonusLink Points throughout the entire Campaign Period provided that all the requirements to be eligible to participate in this Campaign stated in these Terms and Conditions are satisfied.
