

**“SHELL BONUSLINK PREMIUM ITEM VOUCHER REDEMPTION ON *BLINK* APP”
TERMS & CONDITIONS**

1. The Shell BonusLink Premium Item (“SBPI”) Voucher Redemption on ***BLINK*** App (“Campaign”) is organised by BonusKad Loyalty Sdn Bhd (Registration No. 199701022703 (438200-T)) (“BonusLink”).

2. This Campaign is open to all registered BonusLink Members (“Members”) who are residing in Malaysia and above the age of eighteen (18). This Campaign is strictly not applicable to EU residents.

3. This Campaign will commence from 11 October 2021 to 31 December 2021 (“Campaign Period”) and is applicable to all participating Shell retail stations in Malaysia (“Shell Stations”).

4. During the Campaign Period, Members will be able to use their BonusLink Points to redeem SBPI based on the table below:

3	Bath Towel – Purple/Mauve	2,600 BonusLink Points
4	Backpack – Grey	3,500 BonusLink Points
5	Umbrella - Blue	4,000 BonusLink Points

5. Members will be able to use their BonusLink Points to redeem:

(i) at participating Shell ‘On-The-Spot’ outlets; or

(ii) via ***BLINK*** App.

6. Stocks are limited and will be subject to availability on a first-come, first-served basis.

7. Voucher is available for redemption on ***BLINK*** App from 11 October 2021 – 31 December 2021.

8. Voucher is valid for redemption of one (1) SBPI from 11 October 2021 – 15 January 2022.

9. There is no limit to the quantity of redemption or purchase of voucher, however each Member can only redeem up to a maximum of three (3) times per day.

10. Members may utilise more than one (1) voucher per valid transaction at participating Shell ‘On-The-Spot’ outlet at a time.

11. Voucher is non-returnable, non-refundable, and/or non-exchangeable for cash in part or in full.

12. Voucher may be transferred or gifted to another Member after it has been redeemed or purchased via ***BLINK*** App.

13. Voucher will be displayed in “My Wallet” on the ***BLINK*** App upon successful redemption or purchase.

14. Only Members with valid PIN may make redemptions.
