

**“TOWEL – PURPLE/MAUVE VOUCHER REDEMPTION ON *BLINK* APP”**  
**TERMS & CONDITIONS**

1. The Towel – Purple/Mauve Voucher Redemption on ***BLINK*** App (“Campaign”) is organised by BonusKad Loyalty Sdn Bhd (Registration No. 199701022703 (438200-T)) (“BonusLink”).
2. This Campaign is open to all registered BonusLink Members (“Members”) who are residing in Malaysia and above the age of eighteen (18). This Campaign is strictly not applicable to EU residents.
3. This Campaign will commence from 22 June 2021 to 30 September 2021 (“Campaign Period”) and is applicable to all participating Shell retail stations in Malaysia (“Shell Stations”).
4. During the Campaign Period, Members will be able to use their BonusLink Points to redeem a Towel – Purple/Mauve at two thousand six hundred (2,600) BonusLink Points:
  - a. at participating Shell ‘On-The-Spot’ outlets; or
  - b. via ***BLINK*** App.
5. Stocks are limited and will be subject to availability on a first-come, first-served basis.
6. Voucher is valid for redemption of one (1) Towel – Purple/Mauve.
7. Voucher is available for redemption on ***BLINK*** App from 22 June 2021 – 30 September 2021.
8. Voucher is valid for redemption of one (1) Towel – Purple/Mauve from 22 June 2021 – 25 October 2021.
9. There is no limit to the quantity of redemption or purchase of voucher, however each Member can only redeem up to a maximum of three (3) times per day.
10. Members may utilise more than one (1) voucher per valid transaction at participating Shell ‘On-The-Spot’ outlet at a time.
11. Voucher is non-returnable, non-refundable, and/or non-exchangeable for cash in part or in full.

12. Voucher may be transferred or gifted to another Member after it has been redeemed or purchased.
13. Voucher will be displayed in "My Wallet" on the **BLINK** App upon successful redemption or purchase.
14. Only Members with valid PIN may make redemptions.

## **GENERAL TERMS & CONDITIONS**
