

TERMS AND CONDITIONS – “SAMCE BONUSLINK” PROMOTION

1. The “SAMCE BONUSLINK” **Promotion** (“**Promotion**”) is jointly organised by Shell Malaysia Trading Sdn Bhd (Company Registration No. 196501000279 (6087-M)), Shell Timur Sdn Bhd (Company Registration No. 198401000783 (113304-H)), collectively known as “**Shell**” and “BonusKad Loyalty Sdn. Bhd. (Company no. 199701022703 (438200-T)) (“**BonusLink**”).
2. It is open to all BonusLink Primary and Supplementary Members who are residing in Malaysia and are above 18 years of age (“**Eligible Participants**”). BonusLink reserves the right to disqualify any person that it knows is, or has reasonable grounds to believe is, ineligible for this Promotion as a result of this rule.
3. The Promotion Period is from Sunday, 15th August 2021 (12:01AM) to Friday, 31 December 2021 (11:59PM), both dates inclusive, which can be extended by Shell and BonusLink without prior notice.
4. This Promotion is applicable to all participating Shell retail stations with a Shell Advance MotoCare Express (“**SAMCE**”) in Malaysia, as listed on www.shell.com.my/stationlocator (“**Shell Stations**”).
5. This Promotion encompasses the following offers:
During the Programme Period, Eligible Participants will receive a total of 500 BonusLink Points (“**Bonus Points**”) for completing the “Pre-requisites” listed in point 6.
6. To be eligible for this Promotion, Eligible Participants must fulfil the following (collectively, referred to as the “**Pre-requisites**”):
 - a) Swipe a valid physical BonusLink Card or scan a valid BonusLink Virtual Card via the BonusLink App (“BLINK”) prior to making payment at the cashier and/or payment terminal at Shell Stations; and
 - b) purchase any of the Shell Advance 4T Synthetic grade lubricants (“collectively, **Shell Advance**”) at Shell Stations during the Programme Period; and
 - c) purchase any of Shell FuelSave 95, Shell V-Power 97, and/or Shell V-Power Racing, or any products sold within Shell Select premises or Shell Kedai premises at the participating Shell Stations, (except tobacco products, E-Pay products and Touch N Go transactions) up to the minimum required spend amount of Ringgit Malaysia Ten only (RM10.00) in a single receipt (“**Qualifying Purchase**”).
For the avoidance of doubt, Qualifying Purchases may also be paid via the redemption of BonusLink Points.

 - b) The Promotion Offers do not include any accessories or items that are shown in the promotional materials as it is for illustrative purposes only.

The Bonus Points earned by Eligible Participants for each Qualifying Purchase will be awarded to the Eligible Participants within seven (7) working days from date that the Qualifying Purchase was made. For manual transaction journals (“MTJ”) submitted for Shell Fuels purchase transactions by authorised Shell dealers, the Bonus Points will be awarded to Eligible Participants within six (6) to eight (8) weeks from the date of submission of the MTJ to BonusLink.

To the fullest extent permitted by law, there are no, and Shell expressly excludes and disclaims any representations, warranties, or endorsements, express or implied, written or oral, including but not limited to, any warranty of quality, merchantability or fitness for a particular purpose in respect of the Promotion Offers.
