TERMS AND CONDITIONS

- 4. Ensure rental is not rejected or cancelled by either Owner or Renter under any circumstances.
- 5. Definition of Collect 5X BonusLink Points is 1X Standard BonusLink Points + 4X additional BonusLink Points.
- 5. Voucher is not valid to be used with other promo codes, voucher codes and other products that are on sale or discounted on RentSmart Asia during the Campaign Period.
