

BonusLink X airasia rewards Campaign With Extra 25% Bonus Points

(Terms and Conditions)

1. The BonusLink x airasia rewards campaign with extra 25% bonus points (“**Conversion Programme**”) is jointly organised by BonusKad Loyalty Sdn Bhd (“**BonusLink**”) and BIGLIFE Sdn. Bhd. (“**BL**”) (jointly referred to as the “**Organisers**”).
2. By participating in this Conversion Programme, all participants (“**you**” “**your**” or “**Participants**”) acknowledge that you have read, understood and agreed to be legally bound by these Terms and Conditions and decisions of the Organisers without limitation or qualification.
3. The Conversion Programme will commence from **1 September 2023**, 00:00 GMT+8 and end on **30 September 2023**, 23:59 GMT+8 (“**Redemption Period**”). The Organisers reserve the right to amend or extend the duration of the Campaign at any time as it deems fit without prior notice and/or liability to any Participants.

The Conversion Programme shall be applicable to all BonusLink members with a valid and existing airasia member (having subscribed and registered for membership under the loyalty and rewards program operated by BL under the name “**airasia rewards Program**”) and have a unique registration number known as the “**airasia member ID**” issued by BL at the point of participation in the Conversion Programme. In the event the Participant is not a registered airasia member during the Redemption Period, the Participant is required to sign-up as an airasia member via the airasia website at <https://www.airasia.com/en/gb> or airasia Superapp before participating in the Conversion Programme. 7. The Organisers reserve the right to amend the Redemption Conversion Rate at any time in its sole and absolute discretion without giving any prior notice to you.
8. Participants are required to have a minimum of 1,500 BonusLink Points or airasia points in their respective accounts as per the latest denomination published in the Dedicated Platforms in order to participate in the Conversion Programme.
9. The conversion of BonusLink Points to airasia points and vice versa performed on the airasia xchange platform will take up to twenty-four (24) hours for the conversion to be completed. Any conversion performed via the BonusLink website will take up to two (2) working days to be converted into airasia points. However, should a system failure or technical glitch occur, it may take up to seven (7) working days for the conversion to be processed.
10. Once the conversion is successful, the relevant BonusLink Points or airasia points will be deducted from your BonusLink or airasia member account and are non-returnable and non-refundable under any circumstances.
