



# Terms and Conditions of "RT x BonusLink x Chagee Campaign"

1. The following Terms & Conditions shall apply to the "RT x BonusLink x Chagee Campaign (hereinafter referred to as "the Campaign"), organized by Rakuten Trade Sdn. Bhd. ("Rakuten Trade") and BonusKad Loyalty Sdn Bhd ("BonusKad") (collectively referred to as the "Organizers"). This Campaign shall be effective from 1 November 2023 (00:00) (GMT +8) until 31 December 2023 (16:30) (GMT +8), both dates inclusive, unless advised otherwise by the Organizers ("Campaign Period").

#### Eligibility

- 2. By participating in this Campaign, you hereby agree to be bound by the following Terms and Conditions (as defined hereinafter).
