# "Searching for 4 million Rewards?" Promotion TERMS AND CONDITIONS (ENGLISH)

  July 2024 to 30 September 2024; both core dates are inclusive, and the
  promotion period can be extended at Shell's discretion without prior notice
  ("Promotion Period").
- 2. This Promotion is jointly organized by Shell Malaysia Trading Sdn Bhd, Shell Timur Sdn Bhd (collectively, referred to as "**Shell**") and BonusKad Loyalty Sdn Bhd (Company no. 199701022703 (438200-T)) ("**BonusLink**").

  - a) Malaysians;

  - c) Members who have registered and maintained an account with BonusLink ("BonusLink Members").
